### WHO CAN BE MARRIED AT CALVARY?

As an Episcopal church, we abide by our Church's teaching on Holy Matrimony. Therefore, some guidelines need to be addressed and discussed before plans are made for a marriage to be performed at Calvary Church in Stonington, CT. The Episcopal Church has specific marriage canons:

- A minimum of thirty days' notice is necessary before a marriage, so that there is sufficient time for pre-marital counseling. Pre-marital counseling is required.
- One of the parties must be a baptized Christian (of any denomination).

"In the Name of the Father, of the Son and of the Holy Spirit. Amen.

• In the case of marriage when either partner has been divorced, evidence must be presented that the former marriage has been legally dissolved. This means the priest seeing a copy of the finalized decree. The priest who is asked to solemnize such a marriage must consult with and obtain the consent of the Bishop and must report to the Bishop after the marriage ceremony has taken place. In this situation, it is advisable to begin planning for a wedding at least six months prior to the date so that there may be enough time for counseling and approval by the Bishop.

It is required that the parties sign the DECLARATION OF INTENT. Shown, for your information, below.
